

VIRGINIA AQUARIUM TURTLE TROT VIRTUAL 5K DRAWING
OFFICIAL RULES

1. *How to Enter.* Register for the second annual Virginia Aquarium Turtle Trot Virtual 5K between 12:00 p.m. EST on May 11, 2021 and on June 13, 2021 at 11:59 p.m. EST. Each entrant will be required to provide full contact information including name, valid email address and zip code. No other method of entry will be accepted. Limit one (1) entry per email address.

2. *Conditions of Entry.* All entries become the property of Virginia Aquarium & Marine Science Center Foundation ("Sponsor"). Sponsor has the right, in its sole discretion, to void any entry that appears to have been made by a person not meeting the eligibility requirements of these Official Rules, or to be an automated or duplicate entry, and has the right to permanently disqualify any person it believes has violated these Official Rules. If, for any reason, the promotion is not capable of being run or implemented as planned, including, but not limited to, as the result of infection by computer viruses or bugs, tampering, unauthorized intervention, fraud, or any other cause which is likely to, or actually corrupts, or affects the administration, security, fairness, or integrity of the promotion, then Sponsor reserves the right, in its sole discretion, to withdraw the transmission of any entry and/or to terminate or suspend the promotion at any point and declare a winner based upon the eligible entries received up to that point. any virus or any damage caused to participants' systems. All applicable federal, state and local laws apply. Void where restricted or otherwise prohibited by law.

4. *Prizes for Winning Registrant.* Four (4) Day Passes to the Virginia Aquarium and a Behind-the-Scenes Experience with Sharks and Turtles for four people will be awarded on June 15, 2021. Prizes are as stated and may not be altered or exchanged for perceived value or cash. Prize is non-transferable. The winner is solely responsible for any expenses in connection with the prize not expressly described herein as being awarded including, without limitation, the following: (i) federal, state or local taxes; (ii) any additional expenses not described herein as being awarded associated with the acceptance and use of the prize. Approximate Retail Value: Day passes \$99.80; Behind-the-Scenes Experience - priceless. Participants must be at least 8 years old, 48" tall, and able to climb stairs. Children under age 13 must be accompanied by a participating adult (18 years or older). A maximum of four participants, including children and adults, are permitted on this tour. Phones, cameras, and other loose articles are not permitted on the tour. Prize expires on June 15, 2022.

5. *How winner is chosen.* At the end of the entry, the Sponsor will close the registration link. The Sponsor will then select one winner at random from the entries. The winner will be announced on June 15, 2021. The winner will be notified by email and phone.
